

Merchantrade Asia eRemit Merdeka Campaign

A. TERMS & CONDITIONS

1. The eRemit Merdeka Campaign (hereafter referred as “**Campaign**”) is organized by Merchantrade Asia Sdn Bhd (410591-T) (hereinafter “**Organiser**”).
2. Your participation in the Campaign shall be deemed your unequivocal acceptance to be bound by the Terms and Conditions contained hereunder (hereinafter referred as “**T&C**”).
3. The Campaign period (hereinafter “**Campaign Period**”) starts from 09:00:00 29 August 2018 (GMT +8 / Malaysian Time) and ends on 23:59:59 12 September 2018 (GMT +8 / Malaysian Time).

B. ELIGIBILITY CRITERIA

1. To participate in the Campaign, you (interchangeably referred as “**Participant(s)**”) must:
 - (a) be 18 years and above;
 - (b) be a subscriber and holder of a valid mobile number of any telecommunication service provider(s) in Malaysia ;
 - (c) have a Facebook account; and

2. The GSC Movie Tickets will be transmitted in e-coupon form to the mobile number provided by the successful Participant, by way of SMS.

G. OTHER TERMS

Organiser will not and shall not be held responsible for any delay, error or any other problems in the operation of the Campaign caused by or arising from breakdown, technical malfunction of any computer online system, servers or providers, computer equipment, software, failure of e-mail on account of technical problems and/or traffic congestion on the Internet and/or at any web site or the telecommunications service or a combination thereof, including injury or damage to you or to any other person's computer or mobile phone related to and/or resulting from participating or downloading materials in or in connection with the Campaign.

In no event will the Organiser and their respective affiliates, subsidiaries and related companies, their respective advertising or promotion agencies or their respective officers, directors, employees, members, shareholders, attorneys, representatives and agents (collectively, "Affiliates"), be responsible or liable for any damages or losses of any kind,
